The President and General Committee is pleased to announce that Club Lusitano has entered into a reciprocity arrangement with The Shanghai Roosevelt Club.



Club Lusitano members may enjoy the benefits of the reciprocity arrangement with effect from 1 April 2026.

The Shanghai Roosevelt Club is prestigiously located in the Shanghai Bund and housed on the 3/F of a 1920s mansion that was formerly the Shanghai HQ of Jardine and Matheson.

The Roosevelt Family redeveloped the building in 2008 and committed to preserve the history and restore the past glory of the architecture. Established in 2010 the SRC is a stylish lifestyle establishment featuring premium wines and gourmet foods that embodies the vibrant cultural and social spirit of the city of Shanghai serving as a high-end social and business platform for entrepreneurs, executives, investors, and cultural leaders.

The House of Roosevelt offers facilities designed to provide a luxurious and comfortable experience for its members and guests including numerous private banquet rooms, a cigar lounge and bar. The clubhouse does not have a communal restaurant facility however Club Lusitano members may book function rooms for private dining or enjoy the wine bar and cigar lounges. Dining is primarily Chinese cuisine though international options may be arranged. Club Lusitano members are also welcome to dine at the Sky Restaurant & Bar on the 8/F Rooftop Lounge which has breathtaking views of the Huangpu River.


RECIPROCAL AGREEMENT
BETWEEN
SHANGHAI ROOSEVELT CLUB ("SRC") and CLUB LUSITANO ("CL") HONG KONG

The undersigned clubs hereby enter into this reciprocal agreement whereby members of each club may use the facilities of the other affiliate club subject to the rules and by-laws of the club and the availability of facilities at time of visit.


1. Neither club is responsible for the acts of its reciprocal affiliate other than for the purpose of providing reciprocal arrangements for its members.
2. The reciprocal arrangements apply only to bona fide members and their family members of the affiliated club.
3. For the purposes of this reciprocal agreement a Club Lusitano member includes full member, Permitted User (corporate and individual) and spouses who hold membership cards.
4. Club facilities will be made available only to reciprocal members visiting our respective cities and not to members who have taken permanent residence or extended residence (over 2 months cumulatively a year) within sixty kms of either clubhouse.
5. **Letter of Introduction (LOI)** shall be presented to the club being visited and must be produced upon request whilst on premises by any member of staff.
6. Members of each club shall be entitled to visit the other club no more than twenty-one days (21) in any calendar year. For the purposes of clarity, the twenty-one days are to be consecutive days and **not exceed more than two block occasions** per year.
7. Guest privileges are subject to the rules, regulations, and policies of the host club. Each club reserves the right to deny or revoke a visitor's privileges at any time.
8. Reciprocal members are permitted to entertain guests subject to the rules of the host club.
9. Reciprocal members are required to settle all accounts at time of purchase or before departure according to each club's payment policy. Neither club will be liable in any manner for costs incurred by their members when using the reciprocal club.

10. Reciprocal members desiring to visit the affiliated club must make arrangements ahead of time through their home club's membership department which shall send a fax, letter, or email to the reciprocal club notifying it of the impending visit.

This agreement shall become effective immediately upon signature by both Clubs, and shall remain in effect until termination by either Club giving reasonable written notice, defined at least one month in advance, except that pre-arranged commitments such as member bookings of facilities, falling then after shall continue to be honoured.
