It gives us great pleasure to announce that the General Committees of both Club Lusitano ("CL") and The Hebe Haven Yacht Club Limited ("HHYC") have entered into a Reciprocal Club Arrangement to allow their respective Club members to enjoy and benefit from the amenities of the reciprocating Club.

The arrangement and the access privileges are subject to certain Terms and Conditions which are outlined in the attached.

This agreement shall become effective immediately upon signature by both Clubs, and shall remain in effect until termination by either Club giving reasonable written notice, defined at least four months in advance, except that pre-arranged commitments such as member bookings of facilities, falling thereafter shall continue to be honoured.

Reciprocal Club Arrangement Between Club Lusitano and Hebe Haven Yacht Club <u>Terms and Conditions</u>

General

- 1. The Hebe Haven Yacht Club Limited ("HHYC") and Club Lusitano ("CL") mutually agree to allow its members the use of their respective facilities during their normal operating hours up to three times per calendar month per member.
- 2. Advance notification of visit must be made at least 30 minutes ahead of arrival and direct with the reciprocating club during office hours between the hours of 9.00am and 5.30pm Monday to Friday, and 9.30am to 1pm Saturday. No reciprocating club shall accept walk-ins (i.e., visits without advance notification/booking). Should parking be required at HHYC the vehicle registration should also be provided at the time of booking, and is subject to availability.
- 3. Membership cards are to be produced by the visiting member upon entering the premises or upon request by Club staff at any time whilst on the Club's premises.
- 4. The management of the host Club has the right to refuse entry or service to any member who visits the reciprocating Club and who refuses to, or fails to produce proof of membership or identification.
- 5. Cancellations may be made in writing by email up to 24 hours before the proposed booking time and date without penalty. Cancellations less than 24 hours may lead to a charge of a cancellation fee in the sum of HK\$50 which is to be paid by the member direct to the Club in which the booking was made. No further bookings shall be received from that member until such cancellation charges have been settled.
- 6. Bookings followed by NO SHOW (i.e. no cancellation received or no attendance) will be subject to a HK\$150 penalty which is to be paid by the member to the Club in which the booking was made. No further bookings shall be received from that member until such no-show penalties have been settled.
- 7. Each visiting member may bring up to six family members/guests (total seven persons) per visit. The host club has the discretion to relax the maximum number of guests on a case-by-case basis subject to availability.
- 8. The total number of persons accepted by the host Club from the visiting reciprocal club shall not exceed more than 21 persons per day though this shall be subject to availability. The host club has the discretion to reduce or relax the

maximum number of reservations and number of visiting reciprocal guests on a case-by-case basis subject to availability.

- 9. Chits incurred by HHYC members visiting CL the reciprocating Club member must, with the exception of banquet events (which may require an advance deposit), shall be settled on the day of usage. Chits incurred by CL members visiting HHYC must, with the exception of banquet events (which may require an advance deposit), be settled on the day of usage by Octopus or by signing a chit.
- 10.Payment methods as follows: HHYC members visiting CL shall settle only by way of Credit Card (AE not accepted) or Octopus payment card. CL members visiting HHYC shall settle only by way of Octopus or signing a chit. For banqueting events, a deposit is payable in advance with the balance to be settled on the day of the event by signing a chit for CL members visiting HHYC, or by way of Credit Card (AE not accepted) or cheque for HHYC members visiting CL.
- 11. A 15% surcharge imposed on each visiting member's total chit applies. This however may be waived for specific activities and promotions as and when stated.
- 12.HHYC and CL mutually agree to offer its members the use of its function venues to host banqueting events. Additional booking and charges may be applicable.
- 13.Respective Club members may be invited to partake in host club events, for example, food festivals & promotions, cultural events, concerts, performances, courses, golf days, open days, sailing regattas etc. Additional charges may be incurred.
- 14.Each member is to respect and abide by all rules and regulations of the host Club these include for example, dress code, use of electronic devices, and are to refrain from offensive or noisy behaviour. The management of each Club has the discretion and right to cancel privileges extended without notice for failure to comply with the host Club's rules, regulations and notices.
- 15.In order not to disturb other patrons of the club, mobile phones and other electronic devices such as tablets and laptops should be set to silent mode whenever in the clubhouse. Mobile phones may be used only within the lift lobbies of CL and on the Balcony and outdoor areas of HHYC.
- 16.Each member is responsible for the conduct of their guests and shall not leave respective club premises whilst guests remain on site.

- 17.Parking: HHYC shall permit visiting CL members parking rights excluding weekends and public holidays at its clubhouse subject to availability and guest hourly parking charges at the prevailing rate (currently \$40 per hour). Parking charges of 3 hours shall be waived upon F&B consumption to the value of \$150 or above with vehicle entry after 12pm and departure before 6pm Monday to Friday (except public holidays). For purposes of clarity waiver of the maximum 3-hour parking charges for F&B consumption is not applicable after 6pm when guest parking rates apply. Parking during weekends and public holidays is not available; special requests for such shall be to the sole discretion of the General Manager or Operations & Facilities Manager. CL members may take note that there are approximately 60 public parking meter spaces on Hiram's Highway within close proximity of HHYC. No parking facilities are available at Club Lusitano.
- 18. The respective General Committees of Club Lusitano and HHYC may amend the terms and conditions and privileges as and when mutually decided.
